

AFFIDAVIT OF ELIGIBILITY, LIABILITY RELEASE AND AGREEMENT

I, _____ represent and warrant that I am _____ years of age and understand and acknowledge that I am submitting this Affidavit to The American Institute of Certified Public Accountants (AICPA) (“Sponsor”) with the understanding that it will be relied upon to determine whether I am entitled to compete as a Finalist in the Finals Round in the Bank On It® Tournament (the “Competition”) and to determine whether I am eligible to receive any prize in connection with the competition, as outlined in the Official Rules which are attached hereto and made a part hereof as Attachment 1.

I understand that my signature on this affidavit is necessary for me to have the opportunity to compete in the Finals, where Finalists will be invited to the NAF Next Conference on July 10, 2018 for the final rounds and potentially the Finalist may receive one of the prizes as set forth in the Official Rules. Each student who wishes to receive any prize must execute this Affidavit/Release/Agreement. Note: All expenses associated with attending the NAF Next Conference are solely the responsibility of the students who participate in the Competition. The AICPA (“Sponsor”) will **NOT** provide any funds for travel or other expenses to any participant or any other individual in connection with the Competition and any individual who attends the conference is responsible for making his/her own travel arrangements.

I understand that I have not yet been granted any prize. All prizes are granted without warranty from Sponsor of any kind, either express or implied, including but not limited to the implied warranties of merchantability, fitness for a particular purpose, or non-infringement.

As provided in the Official Rules, I hereby agree to be responsible for all federal, state and local taxes on my prizes as well as any other costs and expenses not expressly set forth therein. I agree to provide AICPA with any additional information including my social security number and to complete any forms, documents and information that AICPA may reasonably request to comply with all applicable laws and tax reporting obligations.

I warrant and represent that: (1) I have fully complied with the Official Rules of the Competition; (2) I am _____ years old [**Note: If you are under 18 or if you are from Alabama, Nebraska or Puerto Rico, you MUST also have the signature of a parent or guardian on this affidavit or you will be disqualified**]; (3) I am a legal resident of one of the fifty U.S. states, the District of Columbia, Puerto Rico or a U.S. territory, and (4) I have perpetrated no fraud or deception in the Competition or in claiming my prizes. In addition, by signing below, I acknowledge and restate that I agree and consent to all terms and conditions set out in the Official Rules.

I further represent that I am not an employee, officer or director of Sponsor or its parent companies, subsidiaries, affiliates, partners, dealers, interactive or promotional agencies, including without limitation, the Association of International Certified Professional Accountants, Krobe Interactive, LLC or NAF, nor am I a member of the immediate family or household of any employee, officer or director of any Competition Entity.

I hereby grant to the Sponsor and the other Competition Entities the absolute right and permission, without obligation, worldwide, in perpetuity, to use my name, address (city and state), likeness, photograph, picture, portrait, voice, biographical information, and/or any statements made by me regarding the Competition or Sponsor for advertising and promotional purposes in any form of media now existing or hereafter developed without notice or additional compensation, except where prohibited by law.
